## Update 2: Coordination Note Event

A new event called a Coordination Note can be added on Workqueue 9367 (HH/HSPC Unsigned Orders). To add a note, highlight the patient in the workqueue and select **+Add Event** in the action button menu. Set the type to **Coordination Notes** and enter your comments. Then, select **Accept**.
