SUBJECT: DISPOSAL OF MEDICATIONS/CONTROLLED SUBSTANCES

PURPOSE: To provide education to patients and families regarding proper disposal of unwanted medication in accordance with applicable state and federal regulations.

POLICY

Merrimack Valley Hospice (MVH)

- <u>Community</u> Nursing Staff MVH nurses will educate and direct caregivers regarding proper disposal of patients' medications when the medications are no longer needed and/or upon the death of a patient residing in a private residence (including assisted living). MVH nurses may not dispose of medication for a patient discharged alive, if requested to do so.
- **<u>Patients residing in a facility</u>** Medications are disposed by facility staff according to facility policy.

Home Health VNA (VNA) and HomeCare, Inc. (HCI) Nursing Staff are responsible for providing information to patients and families regarding unwanted medication disposal. VNA and HCI staff may not dispose of medications but may supervise the disposal of medications by the family in the patient's home.

PROCEDURE

There are two options for disposal of medications:

- 1. *Disposal from Home*: Unused medications may legally be disposed of in two ways:
 - A. Disposal into the water system:

The Food & Drug Administration (FDA) recommends flushing narcotics and other controlled substances down the toilet or sink, instead of throwing them into the trash. Flushing prevents drugs from being accidentally used by children, or anyone else for whom they were not prescribed, including family pets.

Nursing staff will educate families/caregivers following the FDA guidelines for disposal by flushing; refer to Attachment #1 – "Medications Recommended for Disposal by Flushing". This method is the most appropriate route of disposal that presents the least risk of safety. Disposal of CADD pump cassettes and medication bags from infusion devices will be done by cutting the bag and draining the medication into the toilet. If present, nursing staff will supervise when family/caregiver performs medication disposal by flushing.

B. Disposal into Trash (Non-narcotic or other controlled substances)

Federal guidelines released in February, 2007 offer an alternative to flushing medications down the sink or toilet. If this option is preferred, the guidelines below will be taught to families/caregivers.

- 1. To safeguard private health information, cross out the personal information on the medication containers. A black, permanent marker is useful.
- 2. Take unused, unneeded, or expired prescription drugs out of their original containers.
- 3. Mix the prescription drugs with flour (coffee grounds, unused kitty litter, or salt may be used) and put them in impermeable, non-descript containers (such as empty cans with lids or zip-lock type plastic bags). This ensures that the drugs are not diverted (that is, someone other than the patient using the medication), or accidentally ingested by children or pets. Multiple medications may be placed together in a single, large container that can accommodate larger volumes of waste.
- 4. Ensure that the drugs are unusable and prevent the unintentional or intentional ingestion of discarded medications by following the actions listed below:
 - i. Liquid Medications: Add flour, kitty litter, coffee grounds, or salt to the original container and replace the container's cap (a funnel is helpful).
 - ii. Tablets and Capsules: Add water to the container/zip-lock bag, followed by flour, kitty litter, coffee grounds, or salt. Replace the container's cap/secure bag
 - iii. Suppositories: Add flour, kitty litter, coffee grounds, or salt to the container/zip-lock bag, and replace the container's cap/secure bag.
 - iv. Transdermal Patches: Using disposable gloves, remove patches from the packaging or the patient's skin. Immediately fold the patch, sticky sides together, and flush it down the toilet. When flushed immediately, the patch cannot be accidentally used by children, or anyone else for whom it was not prescribed, including family pets. Remove and dispose of gloves and wash hands thoroughly.
 - v. Medicated Ointments and Creams: Mix flour, kitty litter, coffee grounds, or salt into the original container. If this is not feasible, squeeze or scoop medication into a plastic container and mix in the flour, kitty litter, coffee grounds, or salt. Replace the container's cap.
 - vi. Medication/Pill Organizers: Follow the guidelines for tablets and capsules.
- 5. Place all medication containers/zip-lock bags in a plain paper bag to discourage identification and tampering. Dispose of the paper bag in the trash.
- 6. The nurse will document the disposal of medications by family/caregivers using the Medication Disposal form in Mobilewyse. (Located in Add a Form). This documentation includes review of proper disposal techniques if disposal guidance is declined and if disposal is witnessed, the type of disposal method used, and the medications disposed.

2. *Community Disposal* - City and town sponsored unwanted medication take back programs are an effective may to remove expired, unwanted, or unused medications from the home. Disposal reduces the chance that others may accidentally take the medicine, and the risk of medication diversion. Refer to Attachment #2 - "*Community Medication Take Back/Disposal Programs*".

Under no circumstances are medications to be removed from home by HHF staff or volunteers.
